

We Care “Spring Fever” Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE OR ACCOUNT IMPROVES ONE’S CHANCES OF WINNING. OPEN ONLY TO LEGAL U.S. RESIDENTS CURRENTLY RESIDING IN TEXAS WHO ARE 18 YEARS OF AGE OR OLDER AND WHO POSSESS A VALID DRIVER’S LICENSE AT TIME OF ENTRY AND DRAWING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. **Eligibility:** We Care “Spring Fever” Sweepstakes is open to legal U.S. residents currently residing in Texas who are at least eighteen (18) years of age at the time of entry and who possess a current valid driver’s license at the time of entry and drawing. Employees of Direct Energy GP, LLC (“Direct Energy”), CPL Retail Energy L.P. (“CPL Retail Energy”) and WTU Retail Energy L.P. (“WTU Retail Energy”) (collectively known as the “Sponsor”), its subsidiaries, affiliates, sales representatives, distributors, advertising and promotion agencies, and members of each of his or her immediate family (spouses, parents, grandparents, children and siblings, and his or her respective spouses) and those living in the same household of each are not eligible. Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to, and acceptance of, these Official Rules. Winning a prize is contingent upon fulfilling all requirements set forth herein. Sweepstakes begins at 12:01:00 a.m. CT on June 1, 2011 and ends at 11:59:59 p.m. CT on June 21, 2011 (“Sweepstakes Period”).
2. **Methods of Entry**
 - a) Any Direct Energy, CPL Retail Energy or WTU Retail Energy customer, who receives an agency pledge between April 4, 2011 and June 17, 2011, will automatically earn one (1) entry into the Sweepstakes. An agency pledge is defined as: **A payment commitment from a local organization/entity or government agency for assistance with Direct Energy, CPL Retail Energy or WTU Retail Energy customer’s electricity bill.** A Direct Energy, CPL Retail Energy or WTU Retail Energy customer is defined as the natural person in whose name the respective Direct Energy, CPL Retail Energy or WTU Retail Energy account has been issued to and to whom services are billed (no P.O. Box addresses are eligible), subject to the above restrictions. **OR**
 - b) **Mail Entry:** Enter by hand printing on a 3" x 5" card or piece of paper, your full name (as listed on your driver’s license), complete address (P.O. Boxes are not permitted), date of birth, daytime phone number, e-mail (if available), and mail in an envelope to: We Care “Spring Fever” Sweepstakes, Attn: LaKita Williams, 2000 Hwy 287 ByPass, Ennis, TX 75119. All entries must be postmarked by June 21, 2011 and received by June 29, 2011 to be eligible. Information collected from entrants is subject to Sponsor’s privacy policy. In addition to any prize notifications, Sponsor may contact an entrant using the entrant’s address, telephone number or e-mail address provided in his or her entry form to communicate future promotional and marketing campaigns. If you do not wish to receive future promotional/product opportunities and information from Sponsor, please send an e-mail to the Sponsor at unsubscribe@directenergy.com. Notwithstanding anything to the contrary set forth in such policy, all entries received will be shared with a fulfillment house for the purpose of selecting and notifying winners.

Maximum limit of one (1) entry per person, regardless of method of entry.

Sponsor will not be responsible for incomplete, lost, late, postage-due, misdirected or illegible entries. All entries become property of Sponsor and none will be returned. Any questions regarding the number of entries submitted shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by person(s) determined to be tampering with or abusing any aspect of the Sweepstakes.

3. **Winner Selection:** Potential winners will be selected in a random drawing on or about June 30, 2011 conducted an employee of the Sponsor among all the eligible entries received.

4. All Prizes

a) **Grand Prize:** Three (3)

One (1) Direct Energy, one (1) CPL Retail Energy grand prize winner and one (1) WTU Retail Energy Grand Prize winner will receive up to \$1,000.00 US in Electricity credits for a limit of one (1) year. The last day to use remaining credit will be July 6, 2012. After July 6, 2012, if there is any credit remaining on the winner's account, this amount will be deemed forfeited and invalid and can no longer be used for the winner's account. Approximate Retail Value ("ARV") of the Grand Prize is \$1,000.00 US.

b) **Other Prizes:** Ten (15)

Five (5) Direct Energy, five (5) CPL Retail Energy winners and five (5) WTU Retail Energy winners will receive \$300.00 US in Electricity credits to be used during the 2011 calendar year, towards their CPL Retail Energy or WTU Retail Energy bills. The last day to use remaining credits will be December 31, 2011. After December 31, 2011, if there is any credit remaining on the winner's account, this amount will be deemed forfeited and invalid and can no longer be used for the winner's account. Approximate Retail Value ("ARV") of the Prize is \$300.00 US.

In order to claim a Prize, the potential winner must have a residential service address within a Texas service area in which Direct Energy, CPL Retail Energy or WTU Retail Energy is a licensed Retail Electric Provider (the "Service Territory") and a residential account with Direct Energy, CPL Retail Energy or WTU Retail Energy. If the potential winner does not have an account with in the Service Territory with Direct Energy, CPL Retail Energy or WTU Retail Energy, the potential winner will be required to have or open a billing account with Direct Energy, CPL Retail Energy or WTU Retail Energy Residential Services before credits can be delivered. If the potential winner does not have an account with Direct Energy, CPL Retail Energy or WTU Retail Energy and does not choose to open an account with either one of the Sponsors, the prize will be forfeited and will be awarded to another potential winner.

Credits will apply to new or existing service for customers on their Direct Energy, CPL Retail Energy or WTU Retail Energy accounts. Credit must be used on a single account for residential service in the Direct Energy, CPL Retail Energy or WTU Retail Energy Service Territory (no splitting of credit between the Service Territories). In the event of a move

within the Service Territory, Prize credit may be transferred to a new account in winner's name if the winner transfers his or her account to another account for the Sponsor's services.

Electricity will be billed at the then current prices, at the time of consumption. You are not obligated to remain a Direct Energy, CPL Retail Energy or WTU Retail Energy customer after receipt of a Prize and may close your account at any time as may be provided in any contractual relationship with Direct Energy, CPL Retail Energy or WTU Retail Energy. If the residential service account covered by the prize credit is terminated, closed, switched, or cancelled for any reason other than a move to another residential account in the Service Territory, the remaining unused balance of the prize credit will be forfeited. There will be no refunds, partial refunds, or cash payments for unused credit.

Winners who are not currently Direct Energy, CPL Retail Energy or WTU Retail Energy customers must activate their service by August 1, 2011, or they will forfeit their Prizes and another winner will be selected from the remaining entries.

All Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Sponsor is not responsible for any inability of winners to accept or utilize any Prize. Sponsor reserves the right to substitute a prize of equal or greater value for any reason. Prizes displayed on promotional materials are not necessarily the exact prizes being offered and may not reflect the actual prize delivered to the winner. Lost or stolen Prizes will not be replaced.

5. **Winner Notification and Acceptance:** Potential winners will be notified by the telephone number provided on the account or entry on or about June 30, 2011 after the completion of the drawing. Three attempts will be made to contact the potential winner, and if possible, a message will be left for the potential winner to contact the Sponsor with a deadline to contact the Sponsor. If there has been no contact with the potential winner or no returned call by the potential winner by July 6, 2011 by 5:00 pm CST, the potential winner will forfeit the Prize and Sponsor has a right to randomly draw for another potential winner from the remaining entries. Prizes will be awarded to the eligible individual submitting the entry. In the case of Direct Energy, CPL Retail Energy or WTU Retail Energy customers automatically entered into the Sweepstakes, the Prize will be awarded to the natural person named on the account. By entering, entrants agree to be bound to the decisions of the Sponsor, which will be final and binding in all respects. Potential winners may be required to sign and return an Affidavit of Eligibility, Address Confirmation and a Publicity/Liability Release by the return date specified in the prize notification letter, or he or she will forfeit his or her respective Prize. Prizes will be delivered within one (1) week of verification of eligibility. Failure to sign and return the required documentation within the specified time in the prize notification letter, or to comply with any terms or condition of these Official Rules, may result in potential winner's disqualification, forfeiture of his or her interest in the Prize, and the award of the Prize to an alternate potential winner. Any computer, online, telephone, mail or technical malfunctions, delays or human errors that occur in the processing, transmission or receipt of entries, or for inaccurate transcription of entry information, or for entries that are stolen, misdirected, garbled, lost or delayed by computer transmissions or any injury or damage to persons or property, including, but not limited to, entrants' computers, hardware and/or software, which may be caused directly or indirectly, in whole or in part, from entrants' participation in the Sweepstakes or receipt, redemption or use of any Prize. If, for any reason, the Sweepstakes is not capable of being conducted as planned, including, but not limited to, infection by computer viruses, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes beyond the control of Sponsor, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes. Sponsor also reserves the right, in its sole discretion, to disqualify any individual found to be violating these Official Rules or suspected of attempting to disrupt or defraud the entry process or the operation of the Sweepstakes, including, but not limited to, the use of any robotic, automated, macro, script, program or automatic entry method, and Sponsor may prosecute or seek other legal redress against anyone suspected of engaging in these acts.
